The board of directors of the Company (the "Board") wishes to inform the shareholders (the "Shareholders") and potential investors of the Company that, based on the preliminary review of the unaudited consolidated management accounts of the Group for the nine months ended 30 September 2020, the net profit attributable to owners of the Company for the nine months ended 30 September 2020 has significantly decreased by approximately 60% as compared to that for the nine months ended 30 September 2019. Based on such information, the Board expects that the Group may record a significant decrease in its net profit attributable to owners of the Company for the year ending 31 December 2020, as compared to that for the year ended 31 December 2019. Based on the information currently available, the Board considers that such decrease was mainly attributable to the decrease in average market prices of the Group's major products (including but not limited to fluoropolymer products, refrigerant products, organic silicone products, PVC, chlorine alkali, dichloromethane, liquid alkali and other products) as compared to 2019 due to market conditions and the novel coronavirus (COVID-19) pandemic, which led to the decrease in revenue and gross profit margin of the Group during the relevant period.

The information contained in this announcement regarding the Group is only based on a preliminary assessment by the Board with reference to the unaudited consolidated management accounts of the Group for the nine months ended 30 September 2020 and information currently available to the Company, and is not based on any figures or information which have been audited or reviewed by the Company's auditors. Figures and information of the Group are in the course of being considered and checked and are therefore subject to adjustments.
